#### **BY-LAWS**

Below are the recommended bylaw and standing rule amendments for consideration and a vote at the March General Membership meeting.

# BYLAWS ARTICLE VII. COMMITTEES

- h) Yearbook Committee: The Chairman shall select committee members, as needed to assist with compiling information for the yearbook. She shall work with the President, the President-elect, the Vice-President, the Membership Chairman, the Christmas House Chairman, the GFWC-Wyoming President, and any other members as necessary to assemble the yearbook information by July 1.
  - She shall be responsible for collecting current CGC, and Scholarship Committee Community Service Program Committees and subcommittee's expenditure information for publication in the yearbook. She shall make arrangements for printing and have the yearbooks ready to be distributed at the September General Membership meeting.
  - i) She or a member of her committee shall advise the membership keep a record of any contact information changes that may occur during the Club year.

Rational: To update and conform to current practice.

# STANDING RULES Article S-7 Committees

#### **Section S-2. Community Service Program Committees**

Committee chairs are encouraged to use whatever format necessary to elicit suggested project ideas from their members. Any committee may work on special projects at the local, state, national and international level that promote cultural and international understanding.

Disbursements from the Community Service Program allocations require committee approval.

*ii)* Any funds remaining after May 31, will revert to the Community Grant Committee. Upon request, exceptions may be granted by the Board of Directors. If a committee wants to earmark funds beyond the current budget year for a specific project, they must bring the issue to the Board which will have the authority to decide issues regarding the holdover of funds to the next year. An expenditure report shall be submitted to the Kaleidoscope editor by June 1 for publication in the September issue.

The Community Service Program Coordinator shall meet with the committee chairmen. She may chair the Health and Wellness Service Program Committee. She may choose her own co-chair.

## RATIONAL: To update.

- c) Education and Libraries.
  - i) In addition to relevant educational projects, the committee is responsible for awarding scholarships to high school seniors from Laramie County to be used at the Laramie County Community College, the University of Wyoming, or any Wyoming college or licensed or accredited technical or trade school. The committee may also award scholarships to LCCC nontraditional, female-student(s).

The WCLC Arts and Culture Community Service Program encourages members to promote and support art and cultural programs in our community. Our goal is to promote projects that include crafts, dance, drama, food, music, and other manifestations of art and culture that develop skills, awareness, and appreciation. It is designed to inspire clubwomen and ignite within them a desire to make the world a more beautiful, thoughtful, and caring place. Wyoming is the "Cowboy State." Therefore, it is fitting that the capital city of Cheyenne has eight-foot cowboy boots on numerous street corners. The sculptures were colorfully painted in 2004 during a Depot Museum fundraiser called, These Boots are Made for Talking, a joint project of the Cheyenne Depot Museum Foundation and the DDA. The one in the Cheyenne Depot Plaza, sponsored by WCLC, is a tribute to past Wyoming governors. The design was painted by Alice Reed. Alice is a quilter and an abstract artist. Her love of quilting is easy to see in the Cowboy Boot sculpture called "Governors of Wyoming" which stands at the entrance to the Cheyenne Depot. The top of the boot resembles a quilt and the toe of the boot has quilting patterns on it. Names of Wyoming governors and dates served are inscribed on the white squares on the boot. Boot #16:


